
This has reference to NBA's letter of even number dated 21-11-2016 under which UG Pharmacy program offered by your Institution was granted provisional accreditation for 2 years in Tier I by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where UG Pharmacy program of an Institution was granted provisional accreditation for a period of 2 years in Tier I/ II format, the period of provisional accreditation of the program shall be extended from 2 to 3 years subject to the condition that the program meets the essential Pre-qualifiers. The Pre-qualifiers submitted by Sri Ramachandra College of Pharmacy, Sri Ramachandra University, Porur, Kancheepuram, Chennai- 600 116, Tamil Nadu in respect of the UG Pharmacy program have been considered. The program meets all the essential parameters of Pre-qualifiers. Accordingly, the competent authority in NBA has approved the following accreditation status to the program as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation upto 30/06/2019. Sri Ramachandra College of Pharmacy, Sri Ramachandra University, Porur, Kancheepuram, Chennai- 600 116, Tamil Nadu should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.
