REGULATIONS AND SYLLABUS FOR THE FELLOWSHIP IN 'CLEFT AND CRANIOFACIAL ORTHODONTICS'

INTRODUCTION AND RELEVANCE:

The cleft wing of the Department of Orthodontics, has been functioning from the year 2001. An average of 30-40 new cases are treated per year by a trained specialist under the roof of SRIHER (DU). The clinic is staffed by a faculty member who has undergone a Clinical Fellowship in Cleft lip and craniofacial orthodontics with 13 years of clinical experience. Postgraduates from the Department of Orthodontics undergo clinical exposure and attend treatment camps for patients with cleft lip and palate twice a month.

This training program is for orthodontists who wish to sub-specialize in this field and develop the skills needed to treat patients with cleft lip and palate.

As an Orthodontist, the exposure to cleft lip and palate patients during postgraduation is quite limited. SRIHER (DU) is a tertiary care center and has a well-established team handling patients with oral clefts. The center is associated with the TRANSFORMING FACES, Canada. This fellowship offers the specialized skills essential to treat patients with cleft lip and palate, thus rendering yeoman service to the society.

Program Director: Dr. C. Siva Subramanian

Dr. C. Siva Subramanian is currently an Associate Professor in the Department of Orthodontics and Dentofacial Orthopedics and Consultant Cleft and Craniofacial Orthodontist at the Cleft and Craniofacial Centre of SRIHER (DU). Dr. Siva has completed his Clinical Fellowship in Craniofacial Orthodontics in 2013 at the Chang Gung Hospital, Taipei, Taiwan under the Program Director Prof. Dr. Eric Liou.

Aim of the program:

To acquire specialized knowledge in all aspects of cleft and craniofacial orthodontics

Objectives of the program:

To enable each candidate

- 1. To make diagnostic records for patients with cleft palate
- 2. To distinguish and explain the differences in diagnosis and treatment planning of a cleft patient from that of a non-cleft patient.
- 3. To perform the various components of Naso Alveolar Moulding with its pros and cons
- 4. To acquire sound knowledge of fixed appliance mechanotherapy in cleft lip and palate patients
- 5. To develop adequate knowledge of the indications and usage of various expansion appliances
- 6. To plan specific cases requiring distraction osteogenesis
- 7. To acquire knowledge of the indications and usage of external and internal distractors
- 8. To plan orthognathic surgeries for various clinical conditions, perform facebow transfer and fabricate splint.
- 9. To develop a basic foundation to carry out dental research in cleft lip and palate.

REGULATIONS FOR

FELLOWSHIP PROGRAM IN 'CLEFT AND CRANIOFACIAL ORTHODONTICS'

ELIGIBILITY

Candidate for admission to the Fellowship Program in Cleft and Craniofacial Orthodontics shall be required to possess the following qualifications:

- (a) He / she must have qualified for MDS (master's in dental surgery) Orthodontics and Dentofacial Orthopaedics from this University or of any other University recognized as equivalent thereto by the authority of this University and the Dental Council of India and obtained permanent registration from any of the State Dental Councils.
- (b) The admitting authorities of the Sri Ramachandra Dental Center will strictly ensure that every candidate admitted to the Fellowship Program in Cleft and Craniofacial Orthodontics has obtained permanent registration certificate from any one of the State Dental Councils.

REGISTRATION

A candidate admitted to Fellowship Program in Cleft and Craniofacial Orthodontics of Sri Ramachandra Dental Center, Porur, Chennai-600116, shall register his / her name with the Dental Center by remitting the prescribed fees along with the application for registration duly filled in and forwarded to the Medical Superintendent (Dental) of the Faculty of Dental Sciences.

DURATION OF THE COURSE

- (a) The period of certified study and training for the Fellowship Program in Cleft and Craniofacial Orthodontics shall be ONE academic year for the award of Fellowship Certificate.
- (b) No exemption shall be given from the period of study and training.

COMMENCEMENT OF THE COURSE

The academic year for the Fellowship Program in Cleft and Craniofacial Orthodontics would ordinarily commence from the month of December of every academic year.

CUT-OFF DATES

The candidates admitted and registered from 1 December 2023 to 30 November 2024 shall take up their regular examinations during November at the end of one year of the course. The course will begin in December 2023.

COMMENCEMENT OF EXAMINATIONS

There shall be an examination at the end of every module in an academic year – Total of four modules with four examinations. The exams at the end of each of the three modules will be for 50 marks and will be used for formative assessment. The examination at the end of the fourth module will be the final examination for 200 marks and will be used for summative assessment and deciding the issue of the fellowship certificate.

ATTENDANCE REQUIREMENT FOR ADMISSION TO EXAMINATION

No candidate shall be permitted to appear for the examination unless he / she puts in 90% attendance during his / her period of study and training and produces the necessary certificate of study, attendance and progress from the Course Director.

CONDONATION OF LACK OF ATTENDANCE

There shall be no condonation for lack of attendance for Fellowship Program students.

NUMBER OF APPEARANCES

A candidate registered for the Fellowship Program in Cleft and Craniofacial Orthodontics must qualify in the examinations within two consequent attempts from the date of his / her admission, failing which he / she shall be discharged from the course.

MAINTENANCE OF LOGBOOK

- 1. Every Fellow shall maintain a record of skills he / she has acquired during the one year training period certified by the Course Director / Faculty of Departments under whom he / she has undergone training.
- 2. In addition, the Course Director shall involve their Fellows in Group Discussions and participation in clinical conferences.
- 3. Every Fellow will be encouraged to present short title papers in conferences and to make

improvements on it and submit them for publication in reputed medical journals.

- 4. The Course Director shall scrutinize the logbook once at end of every module.
- 5. The logbook should be submitted at the time of clinical / practical examination for the scrutiny of the Board of Examiners.

Award of Certificate

Certificate will be awarded duly signed by the Course Director of the Fellowship Program, Medical Superintendent [Dental] of Sri Ramachandra Dental Hospital. <u>This program does not come</u> <u>under the purview of Dental Council of India and is not an additional registerable</u> <u>qualification with the Dental Council of India.</u>

SYLLABUS

- A. Essential Knowledge
- 1. The trainee should acquire knowledge pertaining to cases of cleft lip and palate.
- 2. Pre- and post-natal growth and development of craniofacial complex.
- 3. Team management or multidisciplinary team approach with other specialities.
- B. Essential Investigation and Diagnostic Procedure1.Using Dolphin cephalometric software to evaluate skeletal discrepancy.2. Flexible fibreoptic naso endoscopy to evaluate Velopharyngeal function.

C. Skills

- 1. Orthodontic preparation of the alveolar segments for alveolar bone graft.
- 2. Fabrication of various expansion devices for cleft collapsed arches.
- 3. Designing distractor device for Anterior maxillary Distraction.
- 4. Construction of surgical splint for cleft orthognathic surgery.
- 5. Mock surgery

D. Attitude

Trainee should develop compassionate attitude towards cleft lip and palate patients and their parents.

E. Communication abilities

The trainee should be able to develop and maintain a good relationship with the various specialities to develop good principles of team management.

Scheme of Examination Conducted at the end of the program

Clinical skill: Practical examination

1. Clinical exam – involves diagnosing and treatment planning for a patient given on the day of exam. The candidate will be required to complete the tests in the stipulated time and answer relevant questions.

OSCE examinations

- 1: OSCE to test basic knowledge 30 marks
- 2: OSCE to test clinical application 70 marks

Theory Paper – 100 marks

- 2 Essays 10 marks each (20 marks)
- 8 Short Notes 5 marks each (40 marks)
- 30 MCQs 30 marks (30 marks)
- Internal assessment Case records (10 marks)

Total marks: OSCE and Theory - 200 marks

Aggregate passing minimum: 50 / 100

Note: Short exams of 50 marks will be conducted at the end of every module for evaluating the understanding and progress shown by the candidates

Scheme of Training Program

Protocols for Training: Module Based Training System- 4 training modules once in three months with **20 working** days of training per module, over one academic year

Total of 80 days (average of 480 hours) in one academic year

- 1. **FIRST MODULE (December Feb)**: Introduction to cleft lip and palate, impression making: 5 patients, bonding of brackets: 5 patients, insertion and activation of 3 expansion appliances, observation of preparations required for orthognathic surgeries and distraction osteogenesis, 1 camp
- SECOND MODULE (March May): Diagnosis and treatment planning for patients requiring orthognathic surgeries, impression making : 5 patients, bonding of brackets : 5 patients, insertion and activation of 2 expansion appliances; treatment planning, facebow transfer and splint fabrication for 1 patient requiring orthognathic surgery, 1 camp
- 3. **THIRD MODULE (June- August)**: Diagnosis and treatment planning for patients requiring distraction osteogenesis; treatment planning, facebow transfer and splint fabrication for 4 patients requiring orthognathic surgeries, treatment planning and usage of external and internal distractor in 1 patient, 1 camp
- 4. **FINAL MODULE(September November)**: Treatment planning and usage of external and internal distractor in 4 patients, presentation of one short study and one review article

Short exams of 50 marks will be conducted at the end of every module for evaluating the understanding and progress shown by the candidates.

Final exam of 200 marks will be conducted at the end of the four modules.
