7. Instructions to Candidates:

a) Candidates who have been allotted through centralized counseling by the MCC of DGHS, New Delhi for admission to M.D./M.S./M.Ch. (Neuro Surgery-6 Years course) Degree courses in the Deemed to be University for the academic year **2022-23**, are advised to report and complete the admission process strictly within the date and time specified in the '**Allotment Letter**' issued by the MCC of DGHS.

b) The candidates should report along with **original certificates** and Proof for payment of tuition fees and other fees preferably by **Electronic Fund Transfer through RTGS** as specified in page No.3.

c) Demand Draft will also be accepted. (cheques/cash will not be accepted).

d) The candidates should bring the following certificates/documents in Original (along with 2 sets of photocopies of the same without fail):-

- i. Provisional Allotment letter issued by the MCC of DGHS, New Delhi.
- ii. Admit Card issued by NBE (should be complete in all respects including photos and signature of candidate and Invigilator. Candidates with incomplete admit card will not be permitted to proceed with the admission process).
- iii. Result/Rank Letter issued by NBE.
- iv. Aadhaar Card (which will be returned after verification)
- v. MBBS Degree Certificate/Provisional Certificate.
- vi.** MBBS Internship Certificate completed on or before 31.07.2022.
- vii. Permanent Medical Council Registration Certificate issued by MCI/NMC or any State Medical Council.
- viii. MBBS Mark Statements (First Year to Final Year).

- ix. MBBS Consolidated Statement of Marks.
- x. MBBS Attempt Certificate (First year to Final year).
- xi. MBBS Transfer Certificate
- xii. MBBS Migration Certificate.
- xiii. MBBS Conduct Certificate issued by the Head of Institution last studied.
- xiv. Community Certificate (if applicable).
- xv. High School/ Higher Secondary School / Birth Certificate as proof of date of birth.
- xvi. Six Passport size & Two Stamp size colour photographs (same as affixed in NEET Admit Card).
- xvii. Any one of the identification proofs (ID Proof as mentioned in the Information Bulletin published by the National Board of Examinations. i.e., Aadhaar Card / PAN Card / Driving Licence / Voter ID / Passport).
- xviii. Passport with 'Student VISA', PIO card or OCI card for Foreign nationals or NRI students who hold Foreign Passports only.
- xix. OCI card holders, even if they opt to come under General Category, have to submit their Passport and OCI card copies, along with originals, for purpose of record.**
- xx. COVID Vaccination certificate (Double doses) (or) RT-PCR Negative report (Test for Covid should have been take within 72 hours prior to date of reporting for admission)**

e) NRI Sponsored candidates:-

Also candidates who fulfill the conditions prescribed by the Hon'ble Supreme Court of India [in its order dated 22.08.2017 passed in W.P.(C) No. 689 of 2017] may apply to the DGHS for allotment under 'NRI sponsored category' as per instructions given by the MCC of DGHS.

f) Who are eligible to be a Sponsorer?

- i) If the mother or father of the candidate is a NRI and residing abroad ordinarily; or
- ii) If the first degree relation of the candidate is a NRI and residing abroad ordinarily and it would include real brother and sister; or
- iii) If any of the 'nearest relation' is a NRI and residing abroad ordinarily. Nearest relation would include:
 - a) Real brother and sister of father i.e., real uncle and real aunt;

- b) Real brother and sister of mother i.e., real maternal uncle and maternal aunt;
- c) Father and mother of father i.e., grandfather and grandmother;
- d) Father and mother of mother i.e., maternal grandfather and maternal grandmother; and
- e) First degree- paternal and maternal cousins.

g) The Sponsored candidates who are allotted under NRI category by the MCC of DGHS should produce the following additional documents:-

- i) Notarized affidavit of the Sponsorer who is a NRI stating that the candidate is his/her relative (mentioning exact relationship) and that the Sponsorer has already extended financial support to the candidate to pursue his/her studies and that the Sponsorer agrees to sponsor the entire fee for the undergraduate course/program to which the candidate has now applied for;
- ii) A certificate issued by the Indian Embassy to the Sponsorer certifying the Sponsor's status as a NRI, and indicating his/her employment/occupation details including annual income;
- iii) A copy of the Passport and Visa of the Sponsorer;
- iv) Certificate issued by any Gazetted Officer of State/Central Government stating the relationship of the NRI Sponsor with the candidate.

- 8.** i. Candidates without the original certificates / documents shall **not** be allowed to take admission in the allotted Medical College.
- ii. Candidates who have deposited their original documents with any other Institute/College/University and come for admission with a certificate stating that“ their original certificates are deposited with the Institute/College/University” shall **not** be allowed to take admission in the allotted Medical College.
- 9. Allotment letter given by the MCC of DGHS for admission shall be subject to fulfillment of all eligibility criteria prescribed by the NMC and also medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and not found medically fit will not be admitted to the course of study to which they are allotted by the DGHS.

10. Hostel facility:-

- i. Standard Rooms with common facilities can be given to the students who want to stay in the Hostel immediately. However, request for allotment of Hostel Room with specific facility will be subject to availability of the same.
- ii. Within 7 days after the last day of the academic year, the hostler should vacate the room compulsorily in order to facilitate annual maintenance work.
- iii. When the hostler reports at the start of next academic session, some other room ear-marked for the 'specific batch of students' in a Block/floor only, will be allotted by the Chief Warden. No student will be allowed to stay in a particular room continuously for entire duration of course.

11. General:-

- i. If a candidate fails to report on the date and time specified by the MCC of DGHS in the allotment order or produce the original Certificates/Documents and/or fails to pay the tuition fee by Demand Draft/Electronic Fund Transfer through RTGS and furnish UTR No. (for NRI Students through Wire Transfer) on the day of admission, he/she will not be permitted to proceed with the admission process. The vacancy arising therefrom will be duly notified to the MCC of DGHS for further action as per rules.
- ii. If any candidate withdraws from the course of study in which he/she was admitted, after the expiry of the cut-off date prescribed for admission to that course of study or in mid-term and the seat is rendered vacant, the first year fee paid will be forfeited and the student will also be required to remit the 'entire course fee' for the remaining years of the course period.
- iii. Students will be governed by all the University rules including rules for refund of fee, disciplinary rules, hostel rules and UGC/NMC Regulations for Curbing the Menace of Ragging etc., as given in the Student Manual of SRIHER (DU). - iv. At the time of admission, candidates should sign declaration/under taking declaring that they shall abide by the rules and regulation of the University including anti-ragging Regulations of the UGC/NMC and observe good conduct and behavior and that they are bound by the University Rules on payment of fees/refund of fees.

- a) All disputes arising in the interpretation and implementation of the provisions in this Prospectus will be referred to the Vice-Chancellor of this Deemed to be University and the Vice-Chancellor's decision shall be final and binding.
